

Counter Terrorism Local Profiles:- Looking at local risks:



WHAT ARE CTLPS?

- CTLPs are documents produced annually by Counter Terrorism (CT) policing annually across all regions & provide a strategic overview of the risk & threat from terrorism-related activity within a specific geographic area.
- They are designed to help inform partnership risk activity in relation to counter terrorism related threats & issues from an informed position.
- They contain key recommendations & actions that are clear & tangible & can be used to inform local partnership Prevent planning.

HOW LOCAL IS THE FOCUS OF CTLPS?

- CTLPs must contain information that is relevant, current & has local context.
- This will mean police analysts 'drilling down' to define the threat to a county, local borough or ward level & utilising information from partnership datasets where applicable.
- It may even relate to a local place of worship, education or health establishment.
- Risk and threat are dynamic and rapidly evolving and it is important that CTLPs are reviewed, refreshed and briefed by CT policing regularly to reflect the local context.

HOW ARE CTLPS SHARED?

- CTLPS are classified police documents which means that information from the documents will only be shared on 'need to know' basis.
- However, there will be a local process to ensure that specific risks identified in the CTLP briefing are shared with all relevant partners at a strategic level but also to staff working in frontline roles.
- This may involve bespoke verbal briefings provided by your local Police Prevent Engagement Officer, Local Authority Prevent lead or NHS England Regional Prevent Coordinator.
- Briefings which may be general or focus on particular themes, for example, mental health or specific venues or locations where extremist operate.
- In some regions police provide a CTLP 'info-graph' on a page which gives a general overview of the levels & types of risk. This may be regularly refreshed to account for the dynamic nature of risk & threat.

SO WHY ARE THEY IMPORTANT?

- Rapidly evolving terror threats, mean that information around local CT issues needs to be shared to a wider spectrum of stakeholders - including Health- to help mitigate these risks.
- This enables local CT partners including Health to effectively plan local CT activity to address threats & risks strategically.
- Health providers should therefore use relevant information provided to them from local CTLP briefings to help inform their Prevent specific risk assessment & organisational workplan - which should be reviewed regularly.
- It is by understanding the threat that we are better able to identify & support vulnerable patients & citizens.

WHERE DOES HEALTH FIT IN?

- The Prevent Duty 2015 mandates that partners including the health sector should contribute to the annual CTLP production, including providing & sharing relevant information which can help inform the final document.
- Local Authorities & NHS England Regional Prevent Coordinators play a central role in this process by ensuring that local health partners can contribute relevant information & data to the annual CTLP collection process- this may be through a verbal request for information, email or formal questionnaire.
- All health providers should ensure that where possible they include any relevant local information which may help create a reliable picture of risk & threat in their local area.
- This for example may include information relating to extremist organisations focusing on your organisation or extremist materials appearing in public areas such as a prayer rooms or on notice boards.
- It may also relate to types of Prevent referrals being identified within your organisation.
- Staff may also notice activity, for example stickers or posters, & these too should be considered.
