

## **Valproate Resources**

To support the implementation of these measures for valproate, the following safety and educational materials are available:

- <u>Patient guide</u>: Provides those taking valproate (or their parent, caregiver, or responsible person) with information on the risks of valproate in pregnancy and the risks to male patients and what they need to do.
- <u>Healthcare Professional Guide</u>: Provides updated information for healthcare professionals
  on the risks of valproate in pregnancy and the risks for male patients, the new conditions
  for valproate prescribing and key points for patient discussions.
- Annual Risk Acknowledgement Form: For female patients starting valproate and at annual review. Used to support and record the discussion between the patient and specialist prescriber on the risks associated with valproate in pregnancy and to record the decision of the countersigning specialist. At subsequent annual reviews only one specialist is required.
- Risk Acknowledgement Form for male patients starting valproate: Used to support and
  record the discussion between the patient and specialist prescriber of the risks associated
  with valproate in males when starting treatment with valproate and to record the decision
  of the countersigning specialist. This is only to be completed at initiation of valproate.
- <u>Patient card</u>: Provides key information for female patients receiving valproate on contraception and pregnancy prevention.
- <u>Pharmacy poster</u>: Provides important actions for pharmacists dispensing valproate to female patients.
- <u>Warning stickers</u>: To be added to packaging of medicine in exceptional circumstances where the original pack cannot be dispensed.
