

Key principles of prescription issue:

- Always confirm with the patient what they already have in stock and what they actually need wherever possible.
- Do not issue any post-dated prescriptions.
- Do not issue or add new stoma items to a patient's repeat prescription (including care home patients)
 unless they have been initiated and approved by an <u>NHS employed</u> or <u>NHS commissioned</u> stoma
 nurse and there is written evidence/a clinic letter in the patients' notes with a written rationale for
 prescribing.
- Do not re-issue any missing prescriptions that have already been supplied to a dispensing appliance contractor (DAC) without investigating.
- Do not issue prescriptions >14 days before they are needed, except if the patient/carer states they need their prescription early for a valid reason (e.g. to cover a holiday) or the patient has been classed as a vulnerable patient.
- Do not issue higher quantities than those recommended in these guidelines, except on the **documented** advice of an NHS employed or NHS commissioned stoma nurse.
- If you are concerned about early prescription requests or high quantities being ordered, **query** the prescription request. Frequent requests for high quantities may indicate that the patient has a leakage problem and needs to be reviewed by a stoma nurse.
- Do not issue a prescription for any item that has already been supplied by a DAC in advance, except in an emergency where the DAC, or NHS employed / NHS commissioned stoma nurse has contacted your practice directly, explained the reasons why, and authorisation has been granted by a prescriber at your practice first. DACs sometimes dispatch the first order for new patients before receiving a prescription it is entirely at your discretion whether you wish to issue a retrospective prescription for these items and you are not legally or contractually obliged to do so. DACs are contractually required to only supply appliances upon receipt of a valid prescription or an emergency request from a prescriber.

Note: These guidelines highlight and recommend effective, high quality, cost-effective stoma products available to prescribe. Prescribers should note that from time to time stoma nurses <u>may</u> recommend alternative products; based on the clinical need of a patient and following a thorough assessment.

When to refer to a Stoma Nurse

It is recommended that all patients with a stoma have their care reviewed every 12 months, but they should be referred sooner if there are problems:

- If a patient/DAC is ordering more than the normal maximum usage per month or prescription requests suddenly increase
- A patient is currently prescribed a non-formulary accessory (Table 2) where a stoma nurse has NOT
 previously approved the item for use
- A patient is experiencing leakage or sore skin
- A patient who is very distressed or is having difficulty managing their stoma.

Patients should be encouraged to telephone the stoma nurses themselves first to avoid a delay in receiving the appropriate support, using the contact numbers below.

Table 1: Ostomy products that should NEVER be prescribed					
Bridges	Not be used as products with different filtering/blocking options available.				
Cotton bag/pouch covers	Patients should be advised to purchase their own. The majority of bags already come with a fabric cover anyway and have an opaque option.				
Deodorants	Should not be required or prescribed. If a bag is correctly fitted no odour should be apparent except when the bag is emptied or changed. If odour is apparent at other times, refer patient for stoma nurse review. Household air fresheners are sufficient and should be purchased at a supermarket.				
Lubricating gels	Not usually required - a few drops of baby oil/olive/corn oil can be used instead.				
Skin cleansers	Cleansers and soaps are not clinically necessary and should not be prescribed.				
Underwear	These are not for hernia support - these are underwear for ostomates. Patients should be advised that they can purchase their own from the manufacturer or other retail outlet.

Note: Older products vs. newer products

Generally, older-style stoma products are more expensive then newer products in the same treatment area. Updating stoma care following review can improve the quality of patient care as well as increasing cost effectiveness.

The tables below outline the **normal maximum usage**. Requests for higher prescribing quantities should **always** be queried.

ADHESIVE REMOVER SPRAYS/WIPES

Use each time stoma bag is changed. Wipes may be more useful for patients with reduced dexterity. Don't prescribe both – it's one or the other not both

BAGS ('POUCHES')

No preferred brand – these are patient specific and should be decided by a stoma nurse.

BARRIER SPRAYS/WIPES (for barrier creams, refer to Table 2)

Should only be used if the skin around the stoma is sore when a bag is changed - no need to use these all the time. Not for prophylactic use. Sprays are more cost-effective than wipes and should be considered first-line. Short-term use and acute prescription only. Refer to stoma nurse if using for >3 months. Don't prescribe both – it's one or the other.

SPRAYS: Closed/ non-drainable: 1-3 cans per month. Drainable or Urostomy: 1-2 cans per month.

BELTS. WAISTBANDS AND ABDOMINAL TUBES

To support stoma bag or use with irrigation. Acute prescription only, no preferred brand – these are patient specific and should be initiated and sized by a stoma nurse. **Normal usage:** 2 per year, but when first initiated only prescribe 1 at a time to allow patient to trial. Not to be confused with Hernia support belts.

DRAINABLE BAG FASTENERS (CLIPS/TIES)

Patients may benefit from a stoma nurse review because newer bags have integral fastenings. No preferred brand – these are pouch brand specific and usually supplied together with the pouches. **Normal usage:** Clips: 2 a month (reusable). Soft ties: 1 per bag. (Both can be prescribed separately)

FLANGE EXTENDERS, STRIPS, SECURITY FRAMES AND TAPES

Irregular or sudden increase in prescription requests should trigger further investigation as to why. **Normal usage:** 1-3 boxes per month. (Should not be used with closed one-piece pouches)

FLANGES ('BASEPLATES')

No preferred brand – these are pouch specific. Note: flanges are changed every 2-3 days, so you should expect to prescribe a smaller number of flanges per month than bags. **Normal usage:** 10-15 flanges per month (change every 2-3 days).

HERNIA SUPPORT BELTS/GIRDLES

Only to be prescribed if patient has developed a parastomal hernia or is undertaking heavy manual work/strenuous activity and at risk of developing hernia. Can only be prescribed if measured/ recommended by a stoma nurse. Acute prescription only. No preferred brand – these are patient specific and should be decided by a stoma nurse. *Normal usage:* 1 only until proven effective, then 3 per year. **Not to be confused with pouch belt.**

IRRIGATION KITS

Normal usage: 1 kit per year, kit is initially supplied by the Stoma Team & replacement items prescribed as needed. (Patients must be assessed as suitable & then taught technique by a Stoma Nurse).

POWDERS

These should only be used if the skin around the stoma is wet, raw or broken. There is no need to use these all the time. Not for prophylactic use. Short-term use and acute prescription only. If used for >3 months, refer to stoma nurse for review. **Normal usage:** 1 bottle on alternate months.

PROTECTIVE RINGS, SEALS AND WASHERS

These have different sizes, thicknesses and properties due to variations in fluid absorbency requirement. Stoma nurses may use their professional discretion to recommend other types that are not listed below in special circumstances for specific patients. *Normal usage:* Only 1 per bag required.

In some instances, medication will be required to treat or manage stoma complications. These include instances of high output, granulomas and peristomal irritation or ulceration. All medication has been endorsed by the ASCN and follows their evidence-based guidelines.

Clinical assessment of these conditions can be undertaken by the GP, or Specialist Stoma Care Nurses. Within the stoma care setting, the required treatment is recommended and prescribed by Non-Medical Prescribers within the teams based at NBT and UHBW. Treatment is commenced and ongoing assessment is undertaken by the Stoma Care Team to ensure its efficacy and clinical benefit. Where required, cases will be escalated to the wider MDT for further input and advice.
